MISSION STATEMENT:

GRANT GUIDELINES:

Through the application review and grant distribution process, the Greater Sauk Community Foundation matches donated resources with innovative ideas from nonprofit organizations that meet a community need. The Foundation looks for projects that propose practical solutions to current community needs, promote cooperation and collaboration in addressing positive change, promote volunteer involvement, strengthen an organization's effectiveness and stability, and address prevention as well as intervention.

WHO MAY APPLY:

The Foundation welcomes grant requests from organized groups within the Greater Sauk Community Foundation service area (Adams, Columbia, Iowa, Juneau, Richland, Sauk, and Vernon counties):

- Independent nonprofit organizations
- Charitable organizations classified as 501(c)(3) under the Internal Revenue Code
- Local units of state or national organizations
- Groups or clubs organized to sponsor a charitable project

WHAT WE LOOK FOR:

In awarding grants from the Greater Sauk Community Foundation, we favor innovative proposals that:

- Positively impact the quality of life in our service area.
- Promote collaboration and reduce service duplication.
- Originate in the private sector and demonstrate strong volunteer involvement.
- Strengthen the ability of our communities to respond more effectively to needs.
- Help people to help themselves.
- Build upon the strengths of our communities.
- Apply the Foundation's resources where they will make a tangible difference in meeting important community needs.

We attempt to understand both the specific objectives of a request and the long-term benefits that will be derived by the community if the project is funded. Consideration is given to those organizations that are tax-exempt under section 501(c)(3) of the Internal Revenue Code or projects with a charitable purpose.

WE GENERALLY DO NOT FUND:

- Annual campaigns
- Capital campaigns
- Debt retirement
- Direct support of individuals
- Endowments
- Lobbying
- Operating expenses or losses
- Sectarian causes

The Greater Sauk Community Foundation does not discriminate on the basis of race, religion, gender, sexual orientation, age, disability or national origin; we expect grant applicants to hold similar standards.

APPLICATION PROCEDURE:
